- **Mentoring** Definition of the best strategic and technological path to follow and design of the product/service to fit current regulations.
- **Operative support** Drafting of business plan, business model, financial planning, legal support with investors and partners, study of technological improvement path.
- **Networking** Access to our network of investors, potential business partners, communities and professionals.

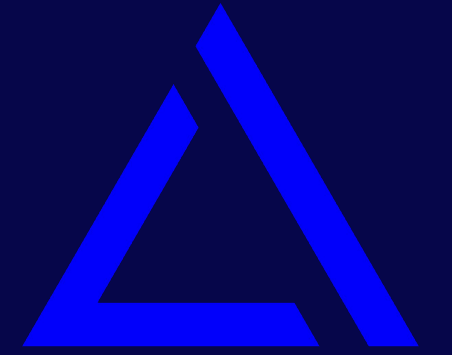

ACCELERATION program

Evaluation process



DISCOVERY & SELECTION

We dedicate up to **4h of free consulting** to all startups we interview.

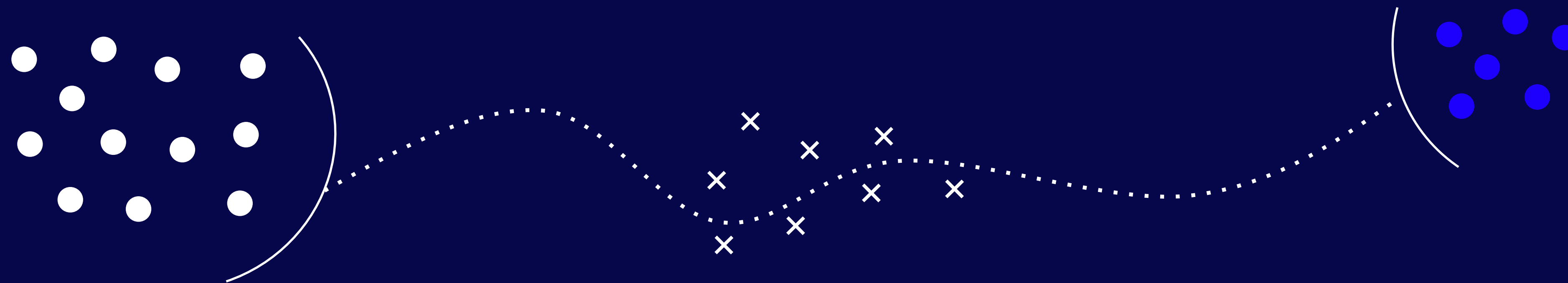
- 1.5h meeting to well-understand how the business idea works.
- 1h internal debriefing to gather insights from the team and in-depth considerations.

At the end of this phase, we present selected startups with the **Highlight Review Table (HRT)**, a document that summarizes the tech, legal, and business needs that emerged in the discovery phase in a 1.5h call.

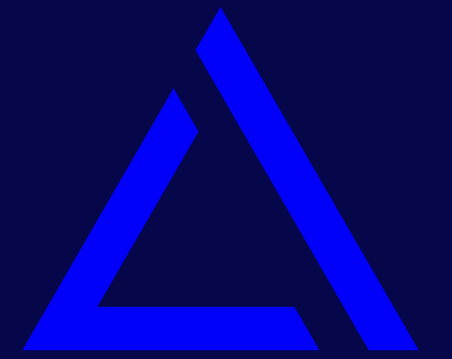
SELECTION (shortlist)

Startups receiving HRT will be evaluated internally by the team and the most promising will be sent a follow-up questionnaire, after which, the best ones will be shortlisted.

All selected (shortlisted) startups will be offered participation in the Aiternalex Acceleration Program.



Acceleration phase



01 ASSESSMENT & IMPROVEMENT

4 weeks

In-depth analysis of the legal, financial, operational, and technological aspects of the startup through legal engineering to identify key improvements.

02 BUSINESS PLAN

Support in drafting the business plan, integrating key improvements into the document (and business model), drafting the financial plan and pitch deck to face the fundraising stage.

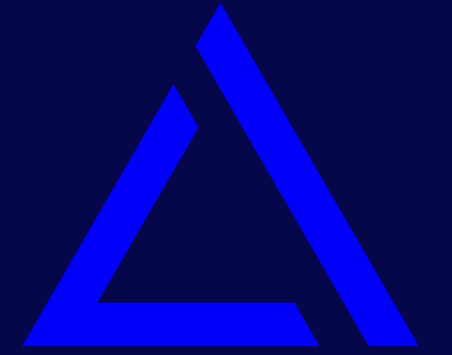
03 PITCH DECK

8-12 weeks

FUNDRAISING STAGE

Support in building the fundraise, investor relations, term sheet negotiation and matchmaking with potential business partners.
